Maharashtra University of Health Sciences, Nashik- Recognition against increased intake MD(Radiodiagnosis) qualification from 1 to 2 seats in respect of students being trained at Institute of Naval Medicine, INHS, Aswini.

Sir/Madam,

I am directed to state that the Board of Governors considered the Council Assessor's Report(s) (3rd June, 2019) on the standard of examination and other teaching facilities for Recognition against increased intake MD(Radiodiagnosis) qualification from 1 to 2 seats in respect of students being trained at Institute of Naval Medicine, INHS, Aswini granted by Maharashtra University of Health Sciences, Nashikand Committee decided as under:-

"The Board of Governors considered the Council Assessor's Report (3rd June, 2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Radiodiagnosis) qualification from 1 to 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Institute of Naval Medicine, INHS, Aswini be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
