NOMINATION –NGIF MEMBERS

- 1. Refer to IHQ,MoD (Navy) letter BA/GIS/39(PC) dated 22 Mar 13 regarding Nomination Policy in respect of NGIF.
- 2. All members of the Naval Group Insurance Scheme are required to file a nomination giving details of nominee(s), to facilitate prompt disbursement of Naval Group Insurance Fund benefits, in the event of unfortunate death. Every year 31 Mar is observed as "NGIF NOMINATION DAY" to facilitate members to update/file their nominations. Notwithstanding observance of the 'Nomination Day' on 31 Mar each year, the changes necessitated due to acquisition of family or otherwise are to be recorded by filing fresh nomination immediately after such change occurs in the family structure of the member. Every such fresh nomination filed shall supersede any nomination filed earlier by the member concerned. The occasions to file/ update NGIF nomination are as follows:-
 - (a) <u>Initial NGIF Nomination</u>. Indian Navy officers/cadets/sailors and Coast Guard officers/naviks on joining their respective initial training institute are to file their initial NGIF nominations.
 - (b) <u>Change/ Updation of NGIF Nomination</u>. It is to be done on the following occasions:-

- (i) On change of family structure due to marriage, divorce/death/insanity of nominee or any addition in family.
- (ii) On promotion from lower deck to officer rank.
- (iii) On promotion to Midshipman.
- (iv) On promotion from Midshipman to Sub Lieutenant after allotment of personal number.
- (v) On allotment of personal number after commissioning in case of Direct Entry Officers.
- 3. The nomination rules are based on the premise that the immediate nucleus family of naval personnel must have assured primacy in so far as benefits to bereaved families are concerned. While making some allowance for dependent parents/brothers/sisters, the following NGIF nomination policy is to be adhered to:-

(a) Married NGIF Member.

- (i) Nucleus Family (spouse/ son(s)/ daughter(s)/ legally adopted children) -66.67% to 100%.
- (ii) Parents (mother/ father)/ brother(s)/sister(s) 0% to 33.33%.
- (b) <u>Unmarried NGIF Member</u>. Unmarried NGIF member may nominate parents/brother(s)/ sister(s) proportionately or in full.
- (c) **NGIF Nomination Not Updated**. In cases, where the deceased has declared the marriage with *IN*, but, the nomination has not been updated, the benefits will be paid as follows:-

(i) Spouse - 66.67%

(ii) Parents - 33.33%

- (d) <u>Family Dispute Case</u>. In case a married NGIF member is involved in family dispute and the case for divorce is subjudice, then the member can nominate his/her children and/or parent(s)/dependent siblings in any proportion. However, this nomination will become null & void on the date of remarriage. The member is then to fill fresh NGIF nomination form as per guidelines at Para 3 (a) above.
- 4. Where no nomination is made/exists, and the deceased is survived by spouse, children and parents, the benefits will be paid to them as follows:-

(a) Spouse and Children- 66.67%

(b) Parents only - 33.33%

- 5. Keeping the above aspects in view, it is requested that personnel be sensitized through the Divisional System so that they are able to take an informed decision whilst making nomination. The prescribed format of nomination is placed at enclosure to this letter and units may be requested to ensure that nomination forms are filled according to the guidelines at Para 3 above.
- 6. It is requested that contents of this letter may be given wide publicity. IHQ,MoD (Navy) letter BA/GIS/39(PC) dated 22 Mar 13 regarding NGIF Nomination policy is hereby cancelled.
