RECRUITMENT TO THE POST OF COOK BY ABSORPTION

1. Applications were invited through proper channel for the post of 'Cook' against the recruitment by Absorption from the persons serving in similar, equivalent or higher grades in the lower formations of the Defence Services, vide Employment News dated 22-28 Apr 2023.
2. A total of **20** in number of applications were received from the applicants, as on closing date of receipt of applications, for recruitment to the post of Cook (by Absorption). On scrutiny of applications, it is observed that all of these **20** applications were found 'ineligible'. The details of applicants found 'ineligible' with grounds for rejection are as follows:-
