#### **NOTICE INVITING TENDER (NIT)**

- 1. A tender is invited for the work as mentioned in Appendix 'A' to this Notice Inviting Tender (NIT).
- 2. The work is estimated to cost as indicated in aforesaid Appendix 'A'. This estimate, however, is not a guarantee and is merely given as a rough guide and if the work cost more or less, tenderer/ bidder will have no claim on that account. The tender shall be based on as mentioned in aforesaid Appendix 'A'.
- 3. The work is to be completed within the period as indicated in aforesaid Appendix 'A' in accordance with the phasing, if any, indicated in the tender form the date of handing over site, which will be on or about two weeks after the date of Acceptance of tender.
- 4. Normally consultants whose names are on the MES/DGNP(V) approved list for the area in which the work lies and within whose financial category the estimated amount would fall may tender / bid. But in case of term contracts, consultants in different groups may tender / bid. In case, where the tender amount is in excess of the financial limit of the consultant [i.e. his class of enlistment] and the Accepting Officer decides to accept the tender / bid, in which event the tenderer / bidder would be required to lodge "Performance Security Deposit" as notified by the Accepting Officer in terms of conditions of Contract. Not more than one tender / bid shall be submitted / uploaded by one consultant or one firm of consultants. Under no circumstances, will a father and his son[s] or other close relations who have business dealing with one another be allowed to tender / bid for the same contract as separate competitors. A breach of this condition will render tenders / bids of both parties liable to rejection.
- 5. **The Deputy Director General and Chief Engineer**, Office of the Director General Naval Project, Naval Base Post, Visakhapatnam 530 014 will be the Accepting Officer here-in-after referred to as such for the purpose of this contract.
- 6. The Technical Bid and Financial Bid (Cover-1 and Cover-2) shall be uploaded by the tenderer/ bidder on or before the date & time mentioned in NIT. 9. A Consultant who is not enlisted for the area in which the work lies but whose name is in the MES approved list of any MES formation and who has deposited standing security and executed standing security Bond may bid without depositing earnest money along with the tender.

#### 10. **PERFORMANCE SECURITY**

- 10.1 Within 28 days of receipt of the letter of Acceptance, the successful consultant shall deliver to the Accepting Officer a Performance Security in favour of DGNP(V) in any of the forms given below for an amount equivalent to 5% of the contract amount:-
  - (a) A Bank Guarantee in the prescribed form.
  - (b) Government Securities, FDR or any other Government instruments stipulated by the Accepting Officer.
- 10.2 Regarding performance security, all conditions are motioned in instructions on filling and submission of tender.
- 11. The DGNP (V) will return the Earnest Money wherever applicable to all unsuccessful tenderers/ bidders by endorsing an authority on the deposit-at-Call receipt for its refund, on production by the tenderer, bidder a certificate of the Accepting Officer that a bonafide tender/bid was received and all documents were returned.

- (e) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- 21.5 An Agent is a person employed to do any act for another, or to represent another in dealings with third person.

#### **ELIGIBILITY CRITERIA FOR UNAPPROVED CONSULTANTS**

# 1. PAST EXPERENCE OF COMPLETED WORKS IN LAST THREE YEARS AND TURNOVER AS APLICABLE:

- (a) Average annual financial turnover during last three consecutive financial years, ending 31 Mar of the previous financial year (i.e. 31 Mar 2020), shall not be less than ₹ 100.00 Lakhs (for Private Company) & ₹ 25.00 Lakhs (For proprietary firm).
- (c) The firm having successfully completed similar works during last 3 years ending last day of month previous to the one in which applications are invited shall be either of the following.
  - (i) Three similar completed works consultancy for project costing not less than ₹ 20.00 Crore (for Pvt company) & ₹ 10.00 Crore (For proprietary firm).

or

(ii) Two similar completed works consultancy for project costing not less than ₹ 25.00 Crore (for Pvt company) & ₹ 12.50 Crore (For proprietary firm).

or

(iii) One similar completed works consultancy for project costing not less than ₹ 40.00 Crore (for Pvt company) & ₹ 20.00 Crore (For proprietary firm).

#### Notes:

- (i) Similar work mentioned above shall mean "experience of consultancy works for preparation of Soil Investigation, architectural & structural drawings including services, preparation of BOQ with detailed estimation of each item, preparation of tender documents and specifications for buildings in Government / PSU Department"
- (ii) To arrive at the value of similar work completed to the present value, escalation @ 5 % per annum for each completed year from the actual completion date (as mentioned in the completion certificate) on the actual value of work completed at SI No. (b), (c)(i), (ii) & (iii) may be added. The value so arrived shall be compared with the above mentioned requirement for the purpose of pre-gualification.

#### 2. **ENGINEERING ESTABLISHMENT:**

(f) Must have all requisite licensed software.

## 3. **COMPANY CREDENTIALS:**

- (i) The firm should have organizational setup, past experience and have reputation in the market as consultant having architectural/structural design capability/ facility commensurate to present scope of work. The firm shall submit documents towards experience of having executed such similar works, response to completion of defects rectification and no contractual disputes in last two years.
- (ii) No joint venture, no consortium partners shall be permitted to participate in the tender.
- (iii) The bidder should have carried out qualifying work completed by their firm and not through any other agency firm of joint venture.
- (iv) The bidder should be Indian Engineer consulting firm with no foreign association. Involvement of any for foreign nationals or associates is strictly not permitted.
