In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the Navy Class II (Gazetted Posts), Recruitment Rules, 1969, in so far as they relate to the post of the Azsistant Armament supply Officer, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to Group 'B' Gazetted posts of Assistant Armament Supply Officer in the Navy, namely:-

- 1. (1) Short title and commencement: These rules may be called the Navy Group 'B' Gazetted Posts (Assistant Armament Supply Officer) Recruitment Rules, 1989.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classification and scales of pay: The number of the said post, its classification and the scales of pay attached thereto, shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit and other qualifications etc: The method of recruitment, age limit, qualifications and other matters connected therewith, shall be as specified in columns 5 to 14 of the Schedule aforesaid.
- Disqualifications: No person,
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to any of the said post: P.T.O.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personnel law applicable to such persons and other party to the marriage and that there are other grounds for so doing, exempt any persons from operation of this rule.

- 5. Power to relax: Where the Central Government is of the opinion that it is necessary or expedient so to do, it may be by order, for reasons to be recorded in writing and in consultation, with Union Public Service Commission, relax any of the provision of these rules with respect to any class or category of persons.
- 6. Saving: Nothing in these rules shall affect reservations, relaxation of age limit and other concession required to be provided for the Scheduled Castes, Scheduled Tribes, Ex-Serviceman and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

R.O. 281.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to Group 'A' Gazetted posts of Medical Physicist and Occupational Therepist in Navy, under Ministry of Defencee, namely :--
- 1. Short title and commencement.—(1) These rules may be called the Navy Group 'A' Gazetted posts (Medical Physicist and Occupational Therapist) Recruitment Rules, 2002.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification and scale of pay.—The number of post, their classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualification, etc.—The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specified in columns (5) to (14) of the said Schedule.
 - 4. Disqualifications.—No person,—

- (a) who, has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person.

shall be eligible for appointment to the said post:
