S.R.O. 43.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in partial S.R.O. 43.—In exercise of the powers conterred by the proviso to article 309 of the Constitution, and in partial supersession of Ministry of Defence, Navy Group 'C' Non-Industrial (Miscellaneous Posts) Recruitment Rules, 1995 in so far as it relates to the post of Security Assistant, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of Recruitment to the post of Security

- 1. Short title and commencement.—(1) These rules may be called the Ministry of Defence, Navy Group 'C' Non-Industrial (Security Assistant Posts) Recruitment Rules, 2008.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification, scales of pay.—The number of the said posts, their classification and the scales of pay attached thereto, shall be as specified in Columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualifications, etc.—The method of recruitment, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (14) of the said Schedule.
 - - (a) who, has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to any of the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons:
- 6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-servicemen, Other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in
