का.नि.आ. 50.—राष्ट्रपति, संविधान के अनुच्छेद 309 के परंतुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए भारतीय नौसेना सिविलियन तकनीकी अधिकारी (समूह 'क' और समूह 'ख') भर्ती नियम, 2003 को, जहां तक उसका संबंध तकनीकी सहायक (ई डी पी) के पद से है उन बातों के सिवाय अधिकात करते हुए जिन्हें ऐसे अधिक्रमण से पहले किया गया है या करने का लोग किया गया है, रक्षा मंत्रालय, नौसेना में तकनीकी सहायक (इलैक्ट्रोनिक आंकड़े प्रक्रमण) के पद पर भर्ती की पद्धित का विनियमन करने के लिए निम्निखित नियम बनाते हैं, अर्थात् :—

S.R.O. 50.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of Indian Navy Civilian Technical Officers (Group 'A' and 'B' posts) Recruitment Rules, 2003 in so far as they relate to the post of Technical Assistant (EDP) the President hereby makes the following rules regulating the method of recruitment to the post of Technical Assistant (Electronic Data Proceesing) in the Ministry of Defence, Navy, namely:—

- 1. Short title and commencement.—1. These Rules may be called the Ministry of Defence, Indian Navy, Technical Assistant (Electronic Data Processing), Group 'B' Gazetted post, Recruitment Rules 2013.
 - 2. They shall come into force on the date of their publication in the Official Gazette.
- ²2. Number, classification, pay band and grade pay or pay scale.—The number of the said post, its classification pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, other qualifications etc.—The method of recruitment, age limit, qualifications and other matters connected therewith shall be as specified in columns (5) to (13) of the Schedule.
 - 4. Disqualification.—No person—
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

- S.R.O. 51.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of the Group 'C' (Electronic Data Processing Posts) Recruitment Rules, 1996, in so far as they relate to Data Entry Operator Grade 'C', except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to Group 'B' Electronic Data Processing posts in Integrated Headquarters, Ministry of Defence (Navy) namely:—
- 1. Short title and commencement.—(1) These rules may be called the Integrated Headquarters, Ministry of Defence (Navy) Group 'B' Non-Gazetted, (Electronic Data Processing Posts) Recruitment Rules, 2013.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classification, pay band and grade pay/scales of pay.—The number of the posts, their classification, pay band and grade pay/scales of pay attached thereto shall be as specified in columns (2) to (4) of the said Schedule.
- 3. Method of recruitment, age limit, other qualifications, etc..—The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
 - 4. Disqualification.—No person,—
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing, and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.—Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Note 1: The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

Note 3: For purposes of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January 2006, (the date from which the revised pay structure based on the 6th Central Pay Commission recommendation has been extended), shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay/pay scale, and where this benefit will extend only for the post(s) for which that grade pay/pay scale, is the normal replacement grade without any upgradation.

S.R.O. 21.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of Indian Naval Armament Service (Group 'A') Recruitment Rules, 1977, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules namely:—

GENERAL

- 1. Short title and commencement: (1) These rules may be called the Indian Naval Armament Service (Group 'A') Recruitment Rules, 2004.
 - (2) They shall come into force from the date of their publication in the Official Gazette.
 - 2. Definitions: In these rules, unless the context otherwise requires:-
 - (a) "appointing authority" in relation to any Grade means the authority empowered under the Central Civil Services (Classification, Control and Appeal) Rules, 1965, to make appointments to that Grade;
 - (b) "cadre" means the group of posts in the Grades as specified in Schedule-I;
 - (c) "cadre" controlling authority" means the Government of India in the Ministry of Defence.
 - (d) "Commission" means the Union Public Service Commission;
 - (e) "Department Promotion Committee" means a committee constituted to consider promotion and confirmation in any Grade;
 - (f) "duty post" means any post included in Schedule-I;
 - (g) "examination" means the combined competitive examination to be held by the Commission for recruitment to the Engineering Services, Group 'A':
 - (h) "Grade" means any of the Grades specified in Schedule-I;
 - (i) "Government" means the Government of India;
 - (j) "regular service" in relation to any Grade means the period or periods of service in that grade rendered after selection and appointment thereto under the rules according to the prescribed procedure for appointment to that grade and includes any period or periods:—
 - (i) taken into account for the purpose of seniority in case of those appointed at the initial constitution of the service.
 - (ii) during which an officer would have held a duty post in that grade but for being on leave or otherwise not being available for holding such post;
 - (k) "Schedule" means a schedule to these rules;
 - (i) "Scheduled Castes and Scheduled Tribes" shall have the same meaning as assigned to them in Clauses (24) and (25) respectively of article 366 of the constitution;
 - (iii) "service" means the Indian Naval Armament Service (Group 'A').
- 3. Composition of the Indian Naval Armament Service: All the duty posts included in the Service as specified in Schedule I shall be classified as Central Civil Service Group 'A' posts.
 - 4. Grade, strength and its review:
 - (1) The duty posts included in the various grades, their numbers and scales of pay on the date of commencement of these rules shall be as specified in Schedule-I.
 - (2) Notwithstanding anything contained in sub-rule (1)
 - (a) The Government may, from time to time, make temporary additions or alterations to the duty post in various grades;
 - (b) The Government may, in consultation with the Commission, included in the Service such posts as can be deemed to be equivalent to the posts included in the Service in status, grade, pay scale and professional content or exclude from the Service a duty post already included in the Service; and
 - (c) The Government may, in consultation with the Commission, appoint an officer to a duty post included in the Service under clause (b) to the appropriate grade on a regular basis and fix his seniority in the grade after taking into account continuous regular service in the analogous grade.

5. Member of the Service:

- (1) The following persons shall be the members of the Service:
 - (a) persons appointed to duty posts under rule 7 and,
 - (b) persons appointed to duty posts under rule 8.
- (2). A person appointed under clause (a) of sub-rule (1) shall, on such appointment, be deemed to be the member of the Service in the appropriate grade to which they were appointed on regular basis before commencement of these rules, applicable to him in Schedule-I.
- (3) A person appointed under clause (b) of sub-rule (1) shall be the member of the Service in the appropriate grade applicable to him in Schedule-I from the date of such appointment.
 - 6. Method of recruitment: The recruitment to the service shall be made by the following methods, namely:—
 - (i) by a competitive examination held in India in accordance with the Engineering Services Examination rules;
 - (ii) by promotion or deputation from another Service or posts in accordance with Schedule-II of these rules;
 - (iii) by special selection in acordance with Rule 13 of these rules.
- 7. Initial constitution of the Service: All existing Group 'A' officers in the Indian Naval Armament Service holding duty posts on regular basis in various grades immediately before commencement of these rules shall be members of the Service in the posts or grades from the date from which they have been regularly appointed to the posts or grades and their respective seniority in the posts/grades shall be the respective seniority as in the existence before the commencement of these rules.

8. Future maintenance of the Service:

- (1) The vacancies in any of the grades referred to in Schedule-I, shall be filled in the manner provided in this nde.
- (2) (a) The percentage of vacancies in the grade of Junior Time Scale of the Service, which is to be filled by direct recruitment through the Combined Engineering Services Examination conducted by the Commission, is given in Schedule-II in respect of Junior Time Scale Grade.

The eligibility conditions for admission to the Examination, the age limit, Educational Qualifications to be possessed by the candidates for appearing at the Examinations and the rules governing the Examination shall be as notified by the Government/Commission from time to time in the Employment News/leading Newspapers.

- (b) The percentage of vacancies in the said grade, which is to be filled by promotion by selection basis, is given in Schedule-II in respect of Junior Time Scale Grade.
- (3) All the vacancies in the grades of Senior Time Scale and above of the Service shall be filled by promotion from amongst the officers in the immediate respective lower grades with minimum qualifying service and educational qualification, if any, as specified in Schedule-II.
- (4) The selection of officers for promotion shall be made on selection basis except in the following cases, namely:--
 - (a) Promotion of officers from the posts in the Junior Time Scale to the posts in the Senior Time Scale of the Service shall be in order of seniority subject to the rejection of the unfit;
 - (b) Grant of Junior Administrative (Non-functional) Grade to the officers of the Senior Time Scale Grade of the Service shall be made in the order of their seniority based on their suitability.
- (1) Every officer on appointment to the service by direct recruitment to posts carrying the pay scale the minimum of which is Rs. 14300 (Rs. 4500 pre-revised) or above, or to posts for which the age of entry is 35 years or above and where no training is involved, shall be on probation for a period of one year. However, persons appointed to the post of Junior Time Scale Grade either by direct recruitment or by promotion, shall be on probation for a period of two years:

Provided that the Controlling Authority may extend or curtail the period of probation in accordance with the instructions issued by Government from time to time:

Provided further, that any decision for extension of a probation period be taken within eight weeks after the expiry of the previous probationary period and communicated in writing to the concerned officer together with the reasons for so doing within the said period.

- (2) On the completion of the period of probation or any extension thereof, officers shall, if considered fit for permanent appointment, be confirmed in terms of the orders of the Government issued from time to time.
- (3) If, during the period of probation or any extension thereof, as the case may be, Government is of the opinion that an officer is not fit for permanent appointment, Government may discharge the officer or revert him to the post held by han prior to his appointment in the Service, as the case may be.

 - (a) shall not be required to serve as aforesaid after the expiry of ten years from the date of appointment, and
 - (b) shall not ordinarily be required to serve as aforesaid after attaining the age of forty years.
- (2) Officer appointed to the Service shall be liable to serve anywhere in India or outside.
- (3) Officers, if deputed, shall be liable to serve in any other Ministry or Department of the Government of India or Corporations and Industrial Undertakings of Government.

11 Disqualification: No person,

- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the Service :

Recruitment by special selection: In special circumstances, recruitment by Special selection of suitable persons, with such qualifications, age limits and other conditions as are considered necessary at any time in the interest of service to the posts mentioned in column 2 of the Schedule-I annexed to these rules shall be made by the Commission by On an Recruitment subject to maintenance of percentage of promotion and direct recruitment in Junior Time Scale Grade as and down in column 3 of Schedule-II,
- 14. Recruitment by deputation: Recruitment by deputation to any posts included in Schedule-I of these Rules from other Services or Departments shall, if necessary, be made by the Government, after consultation with the Commission.
- 15. Power to relax: Where the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Commission relax any of the provisions of these rules with respect to any class or category of persons.
- 16. Saving: Nothing in these rules shall affect reservations, relaxation in age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
- 17. Interpretation: If any question in relation to interpretation of these rules arises, it shall be decided by the Government in consultation with the Commission.
- 18. Residuary matters: In regard to matters, not specifically covered in these rules, the Members of the Service shall be governed by the rules, regulations and orders applicable to the Central Civil Services.
